
THE GRAND JURORS CHARGE THAT, in the County of Prince William, **JORDAN DAVID BAIRD**, on or between about November 1, 2014 to December 31, 2014, being 18 years of age or older and maintaining a custodial or supervisory relationship over J.J., a child under the age of 18 to whom he was not legally married and who was not emancipated, did unlawfully and feloniously, knowingly and intentionally, with lascivious intent, (i) propose that J.J. feel or fondle his sexual or genital parts or that he feel or handle the sexual or genital parts of J.J.; or (ii) propose to J.J. the performance of an act of sexual intercourse, anal intercourse, cunnilingus, fellatio, or anilingus or any act constituting an offense under § 18.2-361; or (iii) expose his sexual or genital parts to J.J.; or (iv) propose that J.J. expose her sexual or genital parts to him; or (v) propose to J.J. that J.J. engage in sexual intercourse, sodomy or fondling of sexual or genital parts with another person; or (vi) sexually abuse J.J. as defined in subdivision 6 of § 18.2-67.10, in violation of Section 18.2-370.1(A) of the Code of Virginia (1950), as amended.

(Class 6 Felony: A term of imprisonment of not less than one year nor more than five years, or in the discretion of the jury or the court trying the case without a jury, confinement in jail for not more than 12 months and a fine of not more than \$2,500.00, either or both.)
